#### **Congressional Veteran Commendation:**

As Americans, we owe our military and Veterans a debt of gratitude which can never be repaid. The Congressional Veteran Commendation (CVC) program is nominations-based, and designed to recognize the sacrifices and devotion to serving our country offered by veterans within Texas' Fourth Congressional District. Candidates that are selected to receive a Congressional Veteran Commendation will be awarded in the following manner:

- Honored at a ceremony for all award recipients in mid-November.
- Will be given a United States flag that has been flown over the U.S. Capitol, along with an announcement of the award entered into the Congressional Record.
- Recipients will have their name and a short biography published on fallon.house.gov under the Congressional Veteran Commendation program page.

#### **Guidelines for Applicants:**

- To be considered for a nomination, veterans must currently reside in Texas' Fourth Congressional District, must have served as active duty military personnel or have been reservists called to active duty, and must have been honorably discharged from a branch of the United States Armed Forces.
- This application is for self nomination ONLY. If you are nominating someone other than yourself, please download our <u>"Nominate a Veteran" application.</u>
- Post-mortem nominations will not be considered.
- You must include a copy of your DD214, and a high-quality photo. Applications without either will not be considered unless you have a special circumstance preventing you from obtaining a copy. Please contact if you have a special circumstance.
- You may choose to include documentation of awards, time served, honors, or other supporting evidence to your nomination. Please make sure any documentation provided is a copy of the original, as our office will not accept original copies.
  - If you choose to provide supporting documentation, you must include them with your final application submission.
