Dear Steering Committee Members,

Thank you so much for your dedicated service to our Republic. When we all entered Congress, we swore an oath to defend the Constitution against all enemies, foreign and domestic.

That oath is like a mission, and now more than ever it demands vigilance against a different kind of threat than the one I faced decades ago as a military member. Today, the threat posed by the radical left, by their focus on subverting our institutions, and by their concerted efforts to weaponize government to undermine President Trump and bend the will of the American people to their own ends is as terrifying as it is dangerous.
